Selectmen's Minutes

Selectmen: Richard Carver, Dave Matthews, Linda Post

4:00 PM Dave Matthews made a motion to accept the Heating Oil Bid for 2800 gallons at \$2.24 for both the Town Office and the Fire Station. Linda Post seconded it. All in Favor.

Bellevue Street (Map 7, Lots 71 & 72) - John Rogers represented Mark & Martha McCarty of 82 Bellevue Street. They request an easement to run under Bellevue Street between lots 71 & 72. The Selectmen informed Mr. Rogers they require to have the meets and bounds on the blue print. The Selectmen requested the system not to encroach on the adjacent paper road.

Scott Bickford sent an email to the Selectmen saying he had to replace the pump on Ocean Avenue. The pump is non repairable. We do not have a spare pump anymore. Dave Matthews made a motion to have Richard Carver talk to Fred Newcomb about the Easement Deed we received for this pump project. Linda Post seconded it. All in Favor.

Linda Post made a motion to have Spring Clean up the week of April 27, 2015 to May 1, 2015. Free Stump Day is going to be May 2, 2015. Dave Matthews seconded it. All in Favor. Bags are available at the Town Office.

Linda Post made a motion to have Frederick Newcomb to do the legal work for the sale of Map 7, lots 93-1 & 95, Town of Owls Head to Stewart Chong on May 1, 2015. Dave Matthews seconded it. All in Favor.

Peter Orne and the Superintendent of RSU 13 would like to meet with the Selectmen and answers any questions they might have in regards to the up coming budget year. The Selectmen said either early morning or later in the afternoon would work for them. Pam Curtis will call and see what would be good for RSU 13.

Richard Carver said the Harbor Committee will be meeting Thursday, March 19, 2015 at 6:00 PM. They will be discussing the needs for public access. Linda Post said they are still waiting to hear the response from Ship to Shore about the easement.
