

## **Selectman's Meeting Tuesday, July 5, 2016**

**4:00 PM** Assessors meeting opened.

Tom Von Malder motioned to approve an abatement for Blue Spruce Joinery for \$132.30. Linda Post seconded. All in favor.

**4:05 PM** Selectman's meeting opened.

Local Road Assistance Program Certification from the Maine Department of Transportation was signed.

The Selectmen discussed the development of the waterfront with Adam Philbrook, Harbor Master, Walter Wotton, Assistant Harbor Master and members of the Harbor Committee and the Wharf Committee. Adam will work on meeting with the committees and other sources to present options for the waterfront.

Bill Leppanen updated the Selectmen that he was waiting to hear from the state for more information on the rail at the fire pond and that he is working on getting four manhole covers raised for paving.

Bill also asked about the speed limit sign on Crescent Beach Road letting the Selectmen know that he had spoken to the Maine DOT and it is up to the town what the limit should be on town roads. Tabled.

Kathryn DerMarderosian informed the Selectmen that Ken Wexler had donated a sign to be posted at the Plasited Preserve and that the Conservation Commission will also post a notice that the Preserve is in the planning and work stage. The Conservation Commission is looking into grants for this project.

Kathryn and the Conservation Commission will also work with Bill Leppanen on the rail for the fire pond.

Tom Von Malder motioned to explore contracting Animal Control services through the Knox County Sheriff's Office. Linda Post seconded. All in favor.

Linda Post followed up on issues on Ginn Point Road and MacPhail's Cemetery.

Tom Von Malder motioned to accept the resignation of Zoning Board of Appeals member John Bragg. Linda Post seconded. All in favor.

Tom Von Malder motioned to appoint Kermit Voncannon to fill the vacant seat on the Zoning Board of Appeals. Linda Post seconded. All in favor.

The Selectmen completed the Ballot for the Maine Municipal Association's Legislative Policy Committee.

The Audit from Accountant James Wadman was reviewed and signed.

Warrants were reviewed and signed.

Tom Von Malder motioned to accept minutes as amended from June 20, 2016. Linda Post seconded. All in favor.
